A Note From The President

As 2010 comes to an end, we have much to reflect upon and a new year to embrace. Our communication has been minimal, but that is not to say the DRU Alumni Association has been absent.

- In August, we re-acquired our House at 124 McCall Street through foreclosure action we took against the buyer. We now face the burdens of property insurance, major repair and past due property taxes we inherited - all requiring great expense in excess of our income. Carroll's deed restrictions and Waukesha's zoning faux pas continue to greatly limit our options for inhabiting it ourselves – or for making the property marketable to potential buyers. We are actively assessing strategy and pursuing leads.
- Carroll presents us with yet another challenge. The school now requires all Greek organizations to carry insurance effective January 1, 2011. Our actives have been quoted "an approximate annual premium of \$5500 and now need to re-assess their financial situation. The DRU Alumni Association has offered to assist the Actives by providing financial assistance as our resources allow. The Active body has accepted our offer."
- We have received a letter from Carroll's Assistant Director of Student Activities indicating that Carroll is now "highly encouraging, but not mandating, that local fraternities go national". As a result, our Actives are feeling pressure to comply with Carroll's recommendation, especially given the new insurance mandate and our continuing inability to successfully resolve the fraternity house situation, both of which situations may or may not be better addressed by a national fraternity organization. We have initiated efforts and an Active/Alumni task force to address the pros and cons of such a change in the Active organization.

With our year ending on a disquieted note, I implore you to show your support by voicing your concerns with Carroll, volunteering your time and resources, attending our events, sending in your membership dues (and if you have some spare change, a donation would be very helpful) and by reaching out to actives and recent alumni.
